### **Introduction:**

During the assessment period, the college has received research grants for a stride project of the University Grants Commission (UGC) and five student projects from KSCSTE.

### 1. STRIDE Project.

STRIDE (Trans- disciplinary research for India's Developing Economy) support to research projects that are socially relevant, locally need-based, nationally important and globally significant. As per the order number F.2-23/2019 (STRIDE-1) dated 03/12/2019, the UGC had approved financial assistance of rupees 21.95 lakhs, (rupees Twenty –One lakh ninety-five thousand only) for the project entitled "Adaptive Speech Recognition for Speech Defects in Malayalam Language" as part of STRIDE project. Dr.Nobert Thomas Pallath (Associate professor, Dept of Electronics) is the PI of the project.

The importance of adaptive speech recognition for speech defects in the Malayalam language lies in its potential to enhance communication and accessibility for individuals with speech impairments. Speech defects can arise due to various reasons, such as neurological disorders, vocal cord damage, or developmental conditions. These individuals often face significant challenges in expressing themselves verbally, which can lead to social, educational, and professional limitations. It's worth mentioning that this project has been sanctioned in 18 colleges all over India, and WMO College is one among them.

## 2. Student Projects.

Another financial aid sanctioned is from KSCSTE (The Kerala State Council for Science, Technology and Environment) is an autonomous body under the ministry of S&T, Kerala, constituted in November 2002 to be an agency for change and development through science and technology.
