## **GOVERNMENT SCHOLARSHIP POLICY**

## E-Grantz' SCHOLARSHIPS

E-grantz is web-based solutions for the timely disbursement of educational assistance to all eligible students of UG, PG and PhD level, which is independent to availing other eligible scholarships.

## Fee Concession to SC/ST/OEC/OBC/General students

All students belonging to SC/ST/OEC are eligible for full tuition fee concession, monthly stipend, annual lump sum grant, university exam fee concession and hostel fee concession, if needed.

**E-Grantz**: For students pursuing post-matric courses approved by the University / Board Eligibility: Students pursuing post-matric courses approved by the university board. Students admitted under merit and reservation quota. Students who belong to the categories of Scheduled castes, other eligible communities, OBCs and other communities who are socially and economically backward including forward castes. Students whose attendance is not below 75% at the end of each month

Income Limit: Scheduled castes and Scheduled Tribes no income limit, OBC(H), OEC Income limit: 6,00,000/- and OBC & General Income Limit: Rs.1,00,000/-

- For Degree Courses: Reimbursement of tuition fee, special fee and exam fee subject to income limit.
- For PG and Professional courses: Lump sum grant, monthly stipend, reimbursement of tuition fee, special fee and exam subject to income limit.
- Fee is sanctioned once in an Academic year and paid to institution's Account.

#### Fee Concession to other students

All other students whose parental annual income does not exceed Rs. 1,00,000/limits are eligible for full fee concession and university examination fee for Under Graduate and Post Graduate courses respectively.

## Other Fee Concessions and Scholarship

# 1. Kerala State Higher Education Council Scholarship (HECS)

**Eligibility**: First year degree students of Science, Humanities, Social Science, Business Studies. Qualifying marks in previous examination: For SC/ST 45% in science and 40% in other subjects. For others 50% in science and 45% in other subjects. Scholarship Amount: For UG Rs. 12000 for first year: Rs.18,000 for second year (1st Renewal); and Rs.24,000 per year (2nd Renewal) for final year; Post Graduation (for continuing education) - Rs.40,000 for first year (3rd Renewal) and Rs.60,000 for second year (4th Renewal)

## 2. State Merit Scholarship (SMS)

**Eligibility**: Applicant should have scored 50% or above in the qualifying exam and should be first year student of UG or PG. Annual income of the parents/guardian from all sources should not exceed Rs.1,00,000/-. Scholarship Amount: For UG Rs. 1250 per annum for 3 years. For PG Rs.1500 per annum for 2 years.

## 3. Hindi Scholarship (HS)

**Eligibility**: Hindi must be one of the subjects in the present studying course. Only I year students are eligible for applying the scholarship. Scholarship Amount: For UG Rs. 500 per month for 3 years; For PG Rs. 1000 per month for 2 years.

### 4. Suvarna Jubilee Merit Scholarship (SJMS)

**Eligibility**: should be first year students of UG or PG. should belong to BPL family. Should have scored 50% or above in the qualifying examination. Scholarship Amount: For UG and

## 5. C.H. Muhammed koya Scholarship (CHMS)

Eligibility: Should belong to Muslim, Latin, and Converted Christian Community and should be a native of Kerala. Should be a girl student studying for the first year graduation or higher courses. Should have scored 50% or above in the qualifying examination. Annual income of the parent/guardian should not exceed Rs.6 lakhs. Scholarship Amount: For UG: Rs.4000 per annum for 3 years for PG: Rs.5000 per annum for 2 years.

# 6. Prof. Joseph Mundassery Scholarship (PJMS)

Eligibility: Meritorious students of Muslim, Cristian, Sikh, Buddha, Parsis, Jains

community who studying in BA/BSc/B. Com in Arts/science colleges

Award: Rs. 15000/- each given to outgoing students, scores 80% in UG final year

Examination and 75% in PG final year examination.

# 7. Post Metric Scholarship (PMS)

Eligibility: Students belonging to economically weaker sections of minority community (Muslims & Christians). 50% or equivalent grade in the previous final examination and the annual income of the parents/guardian from all sources should not exceed Rs. 2 lakhs. Scholarship Amount: Rs.5000 per annum for UG and PG students and maintenance allowance of Rs. 570/- per month for Hosteller & Rs. 300/- per month for Day Scholar.

# 8. PG Indira Gandhi Scholarship for Single Girl Child

Eligibility: Any single girl child, being the only child of her parents, is eligible to apply for the PG scholarship scheme. The scheme is applicable to such a single girl child who has taken admission to the First year master's degree programmes. The age of the girl student should not exceed 30 years at the time of admission. Scholarship Rates: Rs. 2,000/- per month for a period of two years only (10 months in the year) ie. full duration of a PG course. Website: https://scholarships.gov.in

#### 9. LAKSHADEEP SCHOLARSHIP

Department of Education and Ministry of Human Resource Development have launched Lakshadweep Scholarship Scheme. Under the Lakshadweep Scholarship Scheme. beneficiaries will get monthly scholarships to bear the academic expenses. Website: https://scholarships.gov.in

# 10. Post Metric Scholarships for Students with Disabilities (PMSD)

Eligibility: The Scholarships are to provide financial assistance to the parents of students with disabilities for studying in post-metric level. The financial assistance includes scholarship, book grant, escort/reader allowance, etc. Selection of the beneficiaries under these two scholarship schemes is on the basis of merit. # 11. Central Sector Scholarship (CSS)

**Eligibility:** applicant should have passed the Senior School Certificate Examination conducted by CBSE and have secured the total aggregate marks (in first five subjects) equal or above the following minimum marks as per the stream opted by the applicant. Annual income of the parents/guardian from all sources should not exceed Rs. 4.50 lakhs. Scholarship Amount: For UG 1000/- per month. For PG Rs.2000/- per month. # 12. Grants for FISHERMAN's Child (Fisherman Scholarship)

Award: Rs. 400/- per annum - Subject to the date of enrolment. Eligibility: Students of all classes belonging to fishermen community irrespective of income limit. The application forms are available at the office of the Regional Deputy Director of Fisheries, Kozhikode.

## 13. Students Aid Fund

The Student Aid Fund (SAF) is a scholarship scheme available for students enrolled in aided programs. The scholarship funds can be utilized from the Personal Deposit (PD) Account. The selection of students for this scholarship will be based on a merit cum means mode, with a committee responsible for the selection process. The verification of documents will be conducted annually by the Deputy Director of Collegiate Education.

# **Edu Support Scheme**

- 3. Holistic Support: The program recognizes that financial assistance alone may not be sufficient to address all the challenges faced by economically disadvantaged students. Therefore, it aspires to provide holistic support, including mentorship, counselling services, and career guidance, to ensure students receive comprehensive assistance throughout their educational journey.
- 4. Sustainability and Growth: The program strives to establish a sustainable framework to support economically disadvantaged students in the long term. It envisions continuous growth, both in terms of funding and the number of students benefiting from the program. By securing resources and fostering partnerships, the program aims to create a lasting impact on the lives of students in the self-financed departments.

## **Monitoring Committee:**

Constituted a monitoring committee for the Edu support scheme for ensuring transparency and fairness in the application and eligibility process. Principal serves as the Chairman of the monitoring committee. Their role is to provide overall guidance and leadership to the committee, ensuring the smooth functioning of the scheme. Mr. Rasheed N K is appointed as the Convenor of the scheme. The Convenor plays a pivotal role in coordinating the activities of the committee, overseeing the application review process, and ensuring effective communication between the committee members and the applicants.

The committee members should include a diverse group of individuals with relevant expertise and experience. Members could include:

- 1. Representatives from the Management Committee
- 2. Faculty Members: Teachers from the self-financed departments who are familiar with the students and the specific requirements of the program.
- 3. Financial Aid Officer: A designated staff member who has expertise in financial aid and can provide insights into assessing the financial need of the applicants.
- 4. Administrative Staff: Personnel responsible for managing administrative tasks related to the scheme, such as document verification and maintaining records.

The committee is responsible for examining the received applications and verifying the eligibility of the students based on predefined criteria. They should assess the financial need and other relevant factors as outlined by the scheme guidelines. The committee should collectively make decisions regarding the selection and awarding of financial assistance to eligible students. They should ensure fair and unbiased decision-making, considering the available resources and the overall objectives of the scheme.

The committee should maintain accurate records of the application process, including documentation related to the eligibility assessment and final decisions. This ensures transparency and provides a reference for future evaluations and audits. The committee should communicate the decisions and outcomes to the applicants in a timely manner. They should also provide periodic reports to the principal or relevant authorities regarding the progress and impact of the scheme. The committee should periodically review and evaluate the effectiveness of the scheme. They can identify areas of improvement, propose modifications to eligibility criteria or processes, and provide recommendations for enhancing the overall impact of the program.

The decision made by the monitoring committee to provide 100% scholarship to Orphanage inmates and varying percentages (ranging from 30% to 80%) to other eligible students aligns with the objective of the educational support scheme to cater to the specific needs of different student groups based on their circumstances. Here's how the decision can be implemented:

- Orphanage Inmates: The committee has decided to offer a 100% scholarship to orphanage inmates. This means that the semestral fees for these students will be fully covered by the educational support scheme. This decision recognizes the unique challenges faced by orphaned students and aims to provide them with a comprehensive financial assistance package.
- 2. Other Eligible Students: For non-orphaned students who meet the eligibility criteria, the committee has determined that the scholarship percentage will range from 30% to 80%. The specific percentage awarded will depend on factors such as financial need, academic performance, or any other predetermined criteria established by the scheme.



It is important for the committee to ensure that the eligibility criteria and selection process are transparent, fair, and consistent for all applicants. Clear guidelines should be communicated to students, allowing them to understand the basis on which their scholarship percentage is determined.

Additionally, the committee should maintain a robust documentation process to record the decisions made, including the reasons for granting a particular scholarship percentage to each student. This documentation will help ensure accountability and facilitate any future audits or evaluations of the scheme.

Regular communication with the selected students is crucial to inform them of their scholarship percentage and provide any necessary instructions or additional documentation required to receive the financial assistance. By implementing the committee's decision, the educational support scheme can effectively provide financial relief to orphanage inmates and other eligible students, promoting equal access to education and supporting their academic journeys.

# **Policy Document on Freeships**

The policy document aims to outline the freeships provided by WMO Arts and Science College to the students of two self-financing programmes MA Arabic and BA Mass Communication. The college is committed to ensuring equal opportunities for all students, regardless of their financial background.

The semester fee for the BA Mass Communication programmes is Rs. 18750/ which is almost double that for other UG self-financing programmes. As a result, less students are found opting the programme, though they have aptitude and interest. For the MA Arabic programme, the applicant pool is mainly the BA Arabic students graduated from WMO College, and are mainly women from rural areas of Wayanad. In the above context the college management has decided to give freeships of Rs.13750/- and Rs.9000/- respectively to the students of MA Arabic and BA Mass Communication programmes.
