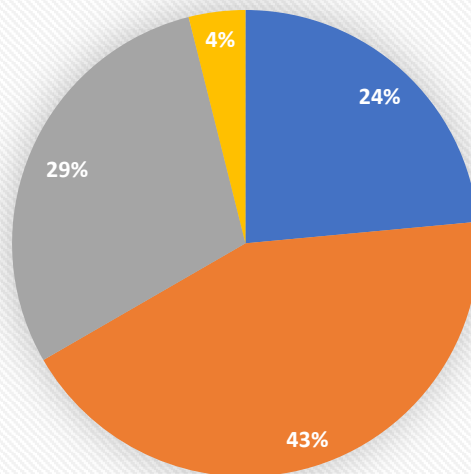

The following actions have been taken as per the analysis of the teachers' feedback by discussing with the authorities concerned:

1. Faculty in the Department of Computer Science suggested modifications to the syllabus of the BCA Programme. The Board of Studies made necessary amendments to the syllabus.
2. Suggested to include a separate module for practical learning in language courses.
3. Informed the members of the Board of Studies regarding the unavailability of prescribed textbooks for language courses.
4. Prepared a proposal for a digital studio and devised a plan for construction.
5. Installed LCD TV or Projectors in PG classrooms.
6. Collected a list of required books from each department and purchased textbooks and reference books in the library.
7. Conducted special sessions for teachers on outcome-based education. The use of Google Drive for documentation in the departments was demonstrated.
8. Conducted centralized internal examinations.
